Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

A meeting was held on April 20, 2021, that included teachers, parents, school staff, and a variety of stakeholders. All individuals provided valuable input into the planning process of the expanded learning opportunities grant plan. The LEA, community, and stakeholders reviewed the seven supplemental instruction and support strategies that needed to be implemented. The stakeholders at the meeting had offered suggestions regarding engaging with community partners, offering expanded learning opportunities, and current behavioral health partnerships that could be incorporated with the plan of action. The LEA allowed all individuals to participate and provide feedback on the expanded learning opportunities grant plan that will be reviewed on May 11, 2021.

A description of how students will be identified and the needs of students will be assessed.

Students will be identified through IAB scores, teacher recommendations, previous years CAASPP scores, and other academic instruments being used by teachers to determine academic progress or regression. Furthermore, assessing the academic needs of the students that include diagnostic and formative assessments. Nevertheless, students will also be identified through barriers faced such as learning loss, provision of health, counseling, or any mental health services, access to school meal program, after school programs, or programs that address student trauma and social-emotional learning.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

The LEA will inform parents, guardians, students, and stakeholders of the opportunities for supplemental instruction and support through monthly meetings, the district website, and monthly newsletters. All individuals involved will have multiple opportunities to be informed and provide input as needed.

A description of the LEA’s plan to provide supplemental instruction and support.

The LEA is planning to offer two weeks of summer school for students in K-8th grade to offer literacy support and address any other learning gaps that are identified through IAB scores, CAASPP scores, formative assessments, summative assessments, and other appropriate diagnostics. Furthermore, the school district has never offered summer school because of a year-round schedule, so having this flexibility will allow for expanded learning opportunities. Moreover, the district will provide technological upgrades to support supplemental instruction and support that replicates education in the 21st century. The district continues to have barriers with connectivity so upgrading the technology will allow for easier access to the curriculum, instructional support, instructional programs provided via the internet, and staff training that will allow for accelerated student academic proficiency in all subject areas. The LEA will hire additional or expand the hours for existing paraprofessional(s) to provide one-on-one support to low-income students, students with disabilities, and disengaged students. Paraprofessionals will also have the opportunity to help with the after-school program, summer school, and professional development training that targets literacy through the summer session. This will build the capacity of the paraprofessionals to help support students identified as low-income, disengaged, and students with disabilities.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

We are bolstering the impact of our Expanded Learning Opportunities Grant funding by ensuring that existing ESSER initiatives such as learning loss mitigation and social emotional supports are further impacted for students and staff. This is an ongoing plan that will benefit students and staff as well as the community for years to come with the strong foundation we are putting forth today. Expanding classified personnel support for students as well as building their capacity to better meet the needs of English Learners, low income, and foster/homeless youth is our ultimate goal and coordinating with other federal Elementary School Emergency Relief funds received will accelerate our plan.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. The plan must be updated to include the actual expenditures by December 1, 2022.

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
