## IPM statement

It is the goal of Piute Moutnain School to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to:

Piute Moutains focus is on long-term pest prevention and control. Our Team continuously upkeepes and maintains school grounds. Cleaning and sanitation both interior and exterior areas helps to protect the health and safty of students, staff and all members of our school.

## Pest identification, monitoring and inspection

Maintenace Staff cleans buildings and office areas daily. Daily and Monthly inspections of building areas such as Caffe, Office, Staff Lounge, Library and Classrooms. In an event where action is needed we use Sticky traps and bait traps that are not accesable to children.

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt<sup>1</sup> from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at [www.cdpr.ca.gov/schoolipm](http://www.cdpr.ca.gov/schoolipm). (Education Code Section 16711)

<sup>1</sup> These pesticides are exempt from all Healthy Schools Act requirements, except the training requirement: 1) products used in self-contained baits or traps, 2) gels or pastes used as crack and crevice treatments, 3) antimicrobials, and 4) pesticides exempt from U.S. EPA registration. (Education Code Section 17610.5)
